## **London & Partners Non-Executive Board Director**

London & Partners is the Mayor of London's promotion agency. We help to attract businesses, investors, events, congresses, students and visitors to the city and assist London businesses to go global. Our aims are to build London's international reputation and create additional jobs and growth for the London economy. We help to deliver the Mayor's economic development strategy and to fulfil the Mayor's pledge for the capital to be a "City for all Londoners".

Established by the Mayor of London in 2011, London & Partners is a not-for-profit public private partnership, funded by the Mayor of London as well as other public sector funding, fees from our commercial partners, in-kind support from the private sector and income from commercial activities. We have offices in London, Beijing, Shanghai, Mumbai, New York, Los Angeles and San Francisco, with representatives in several more countries.

The company has delivered outstanding results, over the last five years, including:

- Contributing more than £1.2bn of economic benefit to the capital with a budget of c.£22m;
- Created or supported 38,000 jobs and helped 1,200 companies to set up or expand in London;
- Generated over £500 million in positive media coverage;

## Notable achievements include:

- Helping create Ride London, a new world class festival of cycling;
- Building London's reputation as Europe's fastest growing tech hub by helping launch London Tech Week and our own Traveltech Lab;
- Attracting the world's largest congress to London with the European Society of Cardiology bringing over 30,000 delegates to London in 2015 worth £15m to the economy;
- Supporting London through our inward investment work to attract twice as many overseas businesses as any other European city;
- Creating award-winning leisure marketing campaigns such as London's Guest of Honour and Fans of London Campaign which reached 300 million people;
- Reaching 28m digital visitors annually through our official online visitor guide, visitlondon.com;
- Launching and operating the new top level domain for London Dot London;
- Being recognised for the last three years as a Sunday Times Best 100 Not-for-Profit Company to work for.

### THE LONDON & PARTNERS BOARD

The Board is made up of 12 Directors. Under the articles of association, the Chairman and one other non-executive director are appointed by the Mayor and the Mayor will approve the appointment by the board of two executive directors – the CEO and COO (the executive with responsibility for the financial affairs of the Company). Other Directors are appointed by the Board following the recommendation of the Nomination Committee with the approval of the members of the Company. The members are the Mayor of London, British Hospitality Association, ABTA, Society of London Theatre and London Chamber of Commerce and Industry.

- Act as an Ambassador for London & Partners and London;
- Make introductions to relevant networks and contacts that will assist London & Partners activities.
